Our firm, Global Kandor Advisors LLC, is registered as an investment adviser with the U.S. Securities and Exchange Commission. Brokerage and investment advisory services and fees differ and it is important for you to understand these differences. Relationships and Services

What investment services and advice can you provide me?
Services: We offer investment advisory services to retail investors. These services include family office services and wealth management services which is a combination of financial planning and investment management. We work closely with you to identify your investment goals and objectives, as well as risk tolerance and financial situation in order to develop an investment approach.
Accounts, Investments, and Monitoring: We provide services to individual, joint, and trust accounts. We primarily use mutual funds, exchange-traded funds ("ETFs") in constructing portfolios. As appropriate we may use private placements and individual bonds in portfolios. We do not make available or offer advice with respect to only proprietary products or a limited menu of products or types of investments. As part of our services, we monitor portfolios and securities in accounts on a regular and continuous basis. We also meet with you at least annually, or more frequently, depending on your needs.
Investment Authority: We provide our services on a perpetual and discretionary basis. We execute investment recommendations in accordance with your investment objectives without your prior approval of each specific transaction. Our engagement will continue until you notify us otherwise in writing. We also offer our services on a non-discretionary basis, which means we are required to obtain your consent prior to executing any trades in your accounts. Therefore, you will make the ultimate decision regarding the purchase or sale of investments in your accounts. However, we do not aggregate orders and therefore you may not receive the same price as other clients.
Account Minimums & Other Requirements: We do not require an account or relationship size minimum in order for you to open/maintain an account or establish a relationship.

Fees, Costs, Conflicts, and Standard of Conduct

What fees will I pay?
Asset-Based Fees: Our asset-based fees for wealth management range from 0.50% up to 2.00% annually. This fee is collected on a quarterly basis and calculated as a percentage of the value of the cash and investments in your account[s] that we manage. This presents a conflict of interest as we are financially incentivized to encourage you to place more assets in your advisory account as you will pay more in advisory fees.
Fixed Fees: Our fixed fee is collected on a quarterly basis and negotiable based on the nature and complexity of the services to be provided and the overall relationship with us.
Other Fees & Costs: In addition to our advisory fee, you will also be responsible for custody fees, account administrative fees, fees and expenses related to mutual funds and exchange-traded funds and applicable securities transaction fees.
Additional Information: You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. When we act as your investment adviser, we have to act in your best interest and not put our interests ahead of yours. Even though we've an institutional relationship with certain custodians or broker-dealers, such as Schwab, Portfolio Resources, and Interactive Brokers to better serve our clients, we do not receive any economic benefit. We do not consider client referrals in our selection or recommendations of broker-dealers or other professionals to our clients.

If required, we will recommend that you open your account with a specific custodian, where we maintain an institutional relationship. However, you ultimately decide where to open your accounts.

How do your financial professionals make money?

Certain financial professionals are compensated based on an agreed-upon annual salary and some receive compensation based on the revenue generated from advisory services, which is distributed in accordance with the legal formation of the firm. This means certain financial professionals have an incentive to increase the asset size in the relationship or solicit new business, taking time away from the day-to-day servicing of existing clients.
